Htun, Myanmar Garment Manufacturers Association General Secretary Daw Khine Khine Nwe, Confederation of Trade Unions of Myanmar Chairman U Maung Maung, the representatives of both local and international Labour Associations, the representatives of NGOs and INGOs, the representatives of Brands, Businessmen, the industry representatives and other dignitaries.

Myanmar Garment Manufacturers Association General Secretary Daw Khine Khine Nwe gave presentation on the topic of "Myanmar Apparel Industry in 2019" and Mr. Filip Lauwerysen (Director of Euro Cham Myanmar) gave presentation about "Trade and Investment with the EU, trends, and considerations". The participants discussed the topics of "Trade and Business", "Skill development and Training needs" and "Industrial Relations and Social Compliance" by using group discussion methods. In the evening, Panel Discussion session was held and after that Buyer' Forum was successfully ended.

PRIORITY

Industrial Zone Bill

Industrial Zones Bill was already submitted and proposed to the Union Parliament. The purpose of the bill is to systematically manage the Industrial Zones for sustainable development. The bill comprises rights and responsibilities of construction businesses and investors in separate chapters respectively. To Download the bill (Myanmar).

Occupational Skill Development Bill

On the webpage of Laws & Rules of Ministry of Labour, Immigration and Population, a comment with the marks of two asterisks can be found. The comment says that the two laws are being drafted as "Employment Restriction Law" and "Occupational Skills Development Law" to replace "1959 Recruitment Restriction Law". As one activity of that drafting process, Ministry of Labour, Immigration & Population, Department of Labour held 5th negotiation meeting on "Occupational Skills Development Bill".

The meeting was held on 1st June 2019 at Yankin Labour Skill Training School and attended by Department of Labor Director General U Win Shein and representatives from relevant departments, organizations and employers' and workers' representatives.

According to the bill, employer has to pay 0.5% of employee's salary as monthly contribution to training funds. Myanmar Garment Manufacturers Association, member of EC U Tun Tun discussed and proposed to change the contribution rate from "0.5%" to "not less than 0.2%" in reason of that local employers may face difficulties due to the contribution.

Moreover, if employer violates any prohibitions of the bill, it will be taken action as "Police case". U Tun Tun again discussed and proposed to remove the provision because, he pointed out, employers will concern about being arrested by police on single violation of this kind of labour law.

ACTIVITY

Garment Sector Coordination Meeting

The local and international Associations, working for the development of the garment sector hold "Garment Sector Coordination Meeting" every 6 months to get the projects are effective and not lapping each other. As the meeting is hosted by the rotating system, Myanmar Garment Manufacturers Association - MGMA and Foreign Trade Association of German Retailers – AVE held "Garment Sector Coordination Meeting" on 10th May 2019 at the first floor of Dakkhina building in Insein GTI compound.

In the meeting, MGMA made a presentation about "MGMA Employer's Package" and other organizations also presented and discussed about their current activities and projects.

Hiring Communication/Public Relation Officer

Myanmar Garment Manufacturers Association is running many projects in collaboration with international organizations for development of the garment sector. To perform the projects' operations, the association conducted job interviews for the posts of Communication/Public Relation Officer | Finance Officer/Accountant and Training Center Director. For the post of Communication/Public Relation Officer, Ko Chan Myae Aung (Contact No. 09 77 373 6790) has been appointed starting from 3rd June 2019.

TRAINING

Myanmar Garment Manufacturers Association (MGMA) is providing trainings with the helps of Ministry of Industries and Ministry of Education. Batches of Basic Sewing Operator trainings are being continuously conducted in Garment Human Resource Development Center (MGHRDC), 400/B, Aung Mingaladone Road, Sint Ngu Ward, Insein. And the association is also providing Garment Skill Development (ToT) training on 1st floor of Dakkhina Building, Insein GTI. Garment Skill Development (ToT) training is one month training, started on 13th May and will end on 12th June 2019.

As MGMA Employers' Package Training Service is being delivered according to the 6 months training calendar, "Dealing with Absenteeism & Turnover" and "Preparing for Audit" trainings were conducted on 2019-04-27 and 2019-05-25 respectively.
