Demonstration by over 2500 workers



On 29 August 2019, in Hlaing Thar Yar, over 2,500 workers demonstrated against the Second Amendment to the law regarding Settlement of Labor Dispute that was promulgated by the Pyitawnsu Hluttaw on 3 June 2019.

The demonstration, which was precipitated by the firing of two workers from the Knitting Factory in Kyauk Ten Township, was organized by Confederation of Trade Unions Myanmar (CTUM) and Industrial Workers' Federation Myanmar (IWFM). In this demonstration, workers demonstrated the law 2nd amendment of settlement of Labor Dispute Law and demanded to address the grievance of two workers fired from Knitting Factory, as soon as possible.

MGMA's statement regarding demonstration in Hlaing Thar Yar and Kyauk Ten Township.

Confederation of Trade Unions Myanmar (CTUM) and Industrial Workers' Federation Myanmar (IWFM) led the demonstration in Hlaing Thar Yar and at the same time 200 workers demonstrated in Kyauk Ten Township.

On 28 August 2019, MGMA released a statement regarding the demonstrations which CTUM and IWFM organized by forcing their basic labor organizations in the factories to draw out the workers to join the demonstrations.

In the statement, the association mentions its concern that organizing the workers who are supposed to be working in the factories to participate in activities outside workplaces during working hours may set back productivity. MGMA refers to the Section 39-A of 2nd amendment of the Settlement of Labour Dispute Law;

"No worker shall conduct to reduce productivity or set back the interests of other workers during the dispute is being resolved"

Discussion on the Settlement of Labor Dispute (Rule) draft

"2012, the law 2nd Amendment of Settlement of Labor Dispute Law was promulgated on 3rd/ June/ 2019 by Pyitaungsu Hluttaw. Therefore, Ministry of Labour, Immigration, and Population is amending the Settlement of Labor Dispute By-law in accordance with second amendment of original law. Ministry of Labour, Immigration, and Population, Labour Affairs Department organized the discussion of the Settlement of Labor Dispute By-law draft on 31st/ August/ 2019.



The discussion held in Yan Kin Township, Skill Training School and representatives and delegates from Labour Affairs Department, employer, employee, International Labor Organization (ILO) were attended.
