

Apparel Sourcing Paris is the biggest garment sourcing show in Europe with more than 600 exhibitors from all over the world. International Garment 25th Anniversary VIP Event and Round Table Discussion

International Garment 25th Anniversary VIP Event and Round Table Discussion was celebrated at National Exhibition and Convention Center (NECC), Shanghai, China on 15th September 2019.



The opening ceremony, round table discussions, group discussions, Working Group meetings were held in this event. Daw Khine Khine Nwe (General Secretary) and U Aung Myo Hein (Central Executive Committee) attended the Meeting as representatives of the Myanmar delegation at the International Garment 25th Anniversary VIP Event and Round Table Discussion.



For the signed contract before Township Conciliation Body, there is no time limitation in Labor Law

At industrial Zones in Hling Thar Yar Township where many garment factories are running, labor strikes are happening again starting from August 2019. Workers and basic labor organizations backs by labor unions and activities used to go on strikes blocking their factories' gates. The workers use blocking the factories' gates as tactic to put pressure on the employers for their interest demands. In this way, the employers are forced to sit many times at the negotiation table in Township Conciliations Body until the workers' demands are complied with. In this situation, the employers tend to comply with the workers' demands without taking into account the following;

- increase of labor cost because of complying with the workers' bonus demands
- period of continuous negotiation in aftermath of the labor strike
- management reform that the employer should consider because of the labor strike

Therefore, the employers make contract with the workers in Township Conciliation Office without carefully consideration and calculation on the facts the agreed. In this regard, the problem is that there is no provision in labor laws for the term of the contact made in front of Township Conciliations Body. The employers should be aware of it when they sit negotiation table at the Township Conciliations Office.

According to Chapter (7) of the 2012 Settlement of Labor Dispute Law, the relevant parties may agree to amend the decision of the Arbitration Body or Arbitration Council after 90 days from the day of coming into force. However, there is no provision for the term of agreement contract made in front of Township Conciliations Body. The employers should be aware of it when they sit negotiation table at the Township Conciliation Office.

It is strongly recommended that the employers should not comply with the workers' demands that the employers cannot afford for long term, in the expectation of that production can be increased easily because of the bonuses. The factory, the agreement contract was made in this way, is likely to have another labor strikes in 6 months with the workers accusing the factory for breaking the contract.

It is strongly recommended that non-long-term rewards remain in line with the expectation that productivity will be boosted. In some factories that used that way, after within 6 months and 1 year, workers would be strike out to employers for accused of breaking a contract.
