## 2020 Year Public Holidays

The Union government pronounced the 2020 Year Public Holidays in Notifications No. 36/ 2019 on 2019, 4<sup>th</sup>, June. The Union Government issued the Public Holiday through by section 25 of the Closing and Transfer Contracts of Offices in the Republic of the Union of Myanmar.

Then, Union Government again released the Notification No. 50/2019 on the date of 2019, August 9. According to the Section 25 of the Law, the Negotiation Instrumental Act in the Republic of the Union of Myanmar has been prescribed as public holidays during the calendar year 2020. The following public holidays would be replaced with another days to avoid the public holiday benefits.

- The Independence Day is on Saturday
- Da Boung Full Moon day on Sunday
- Thingyan Eve Day on Sunday
- Martyr Day on Sunday
- Thadingyut Full Moon Day and the day after full moon respectively on Saturday and
