Union minister of the ministry of Labour, Immigration and Population U Thein Swe, Permanent Secretary and Director General, Deputy Directors, employee representatives and employer representatives, Departmental Officers attended to the meeting. The meeting was organized to overcome the challenges and difficulties for industries with cooperating of government, employer and employees. The employee representatives presented the requests regarding the employees. The employer representatives also presented their requests for their employers. The meeting decided to follow-up some decisions that was decided in the meeting.

Agreement between MGMA and DHL service for our member's cargo and document shipments

We get the agreement with DHL courier service that DHL will discount 25% of freight for all of our member's cargo and documents shipments.

In addition, we can choose optionally to make cargo and document shipments insurance by ourselves.

Loan from the COVID-19 Fund can be applied for the businesses that are affected by COVID-19

The process of getting loan from the COVID-19 Fund to the businesses that are affected by COVID-19 is started on March 30 to April 9, 2020 at Union of Myanmar Federation of Chambers of Commerce and industry (UMFCCI, Mingalar Hall, First Floor) and Region and State Chamber of Commerce and Industry. The government is giving the loan with interest rate 1 percent of during 1-year loan period. Hotel and Tourism, Small and Medium Enterprises and CMP industries can only get the loan from the COVID-19. The loan will be to the borrowers in May and the processes of loaning have to be presented. You can apply the loaning to the Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI) first floor, Mingalar Hall in person or from online.
