Virtual Meeting was held between Myanmar Garment Manufacturers Association (MGMA) and EuroCham Myanmar for the sustainable development in Myanmar garment sector on January 7, 2020. In this virtual meeting, the discussion was about the process of improving the job opportunities from garment factories, the process of extension of order in garment factories from EU buyers, garment sewing trainings and raising the standard of skilled labour from Myanmar Garment Human Resources Development Center(MGHRCDC), improving the relationship between employee and employers, government ministries, European brands and garment related agencies need to corporate together and MGMA need to form and lead a working group in a working group meeting related to change garment factories from CMP to FOB. The representatives from MGMA, EuroCham Myanmar and EU brands attended to this virtual meeting.
